IN 2020, OEW PARTICIPATED IN THE SCOTT MANN ROOFTOP LEADERSHIP TRAINING SEMINAR, WHICH PROVIDED FORMAL INSTRUCTION ON EFFECTIVELY TELLING ONE'S STORY. WARRIORS VOICE ESTABLISHED A PRECEDENT OF SENDING PROGRAM CANDIDATES TO NUMEROUS OEW EMPOWERMENT EVENTS, TO DELIVER OPENING CEREMONY AND CLOSING CEREMONY REMARKS AT SEVERAL RACES AND COMPETITIONS. FURTHER, THE PROGRAM USED A MENTORSHIP APPROACH, TO PROVIDE FEEDBACK TO THE CANDIDATE IN ORDER TO REFINE AND IMPROVE THEIR SPEAKING SKILLS, WHICH CAN IN TURN BE USED TO BENEFIT OEW ITSELF, AT FUTURE EVENTS, OR CAN ALSO BE USED IN THE HONOREE'S PERSONAL PURSUITS OUTSIDE OF OEW. SIGNIFICANT CHANGES TO PROGRAM SERVICES: OEW MADE A SIGNIFICANT CHANGE AND IMPROVEMENT TO ITS METHODOLOGY OF ATTRACTING NEW HONOREES, BRINGING THEM INTO THE ORGANIZATION, AND RETAINING THEIR INTEREST AND PARTICIPATION BEYOND A SINGULAR EVENT. THIS NEW APPROACH ULTIMATELY REDUCES SUICIDE RISK, BY ACTIVELY KEEPING OEW TEAM MEMBERS ALWAYS ENGAGED WITH OEW HONOREES, THUS TRANSFORMING OUR MISSION FROM TRANSACTIONAL TO RELATIONAL. THE IMPLEMENTATION OF AN HONOREE SUPPORT TEAM (HST) NOW SEES OEW DISTRIBUTING ALL HONOREE INTERACTIONS WITHIN ONE OF FOUR LINES OF EFFORTS: RECRUITING, IN-PROCESSING, ONBOARDING, AND COMMUNICATION AND ENGAGEMENT. AN ADDITIONAL BENEFIT OF THE HST IS THAT THROUGH CONTINUAL COMMUNICATION AND ENGAGEMENT, THE ORGANIZATION IS BETTER INFORMED, BY THE HONOREES, AS TO WHAT EVENTS AND ACTIVITIES THEY SEEK TO TACKLE, THEREBY IMPROVING OPERATIONAL PLANNING AND EFFICIENCY. ADDITIONALLY, THE HST MAINTAINS A TELEPHONIC ALERT ROSTER, FOR IMMEDIATE INTERVENTION IN THE EVENT OF A CRISIS. IN 2020 THE TASK FORCE SENTINEL PROGRAM WAS MERGED INTO THE OVERALL SET OF ESTABLISHED PROGRAMS. IN PRIOR YEARS IT WAS KEPT SEPARATE TO MAINTAIN FOCUS ON ITS DEVELOPMENT. IN 2020 BOTH LAW ENFORCEMENT AND MILITARY HONOREES ARE RECRUITED VIA THE SAME PROCESSES AND INCLUDED IN ALL PROGRAMS.
