THE NURSERY PROJECT PROVIDES ESSENTIAL NEWBORN SUPPLIES TO PROVIDE ESSENTIALS, SUPPORT SAFE SLEEP AND ENCOURAGE THE BREASTFEEDING RELATIONSHIP. THROUGH PARTNERSHIP WITH JBLF SUPPORTERS, LOCAL ARLINGTON (VA) MOMS' GROUPS, AND AETNA BETTER HEALTH VIRGINIA, WE HAVE ALREADY SERVED MORE THAN 100 FAMILIES. THIS SUPPORT HAS INCLUDED PROVIDING DIAPERS, BABY BLANKETS, BABY BASICS, STROLLERS, AND INFANT CAR SEATS TO THE NEEDY FAMILIES. THE PROJECT ALSO AIMS TO SUPPORT NEW FAMILIES AS THEY BRING BABIES HOME UNDER UNPRECEDENTED CIRCUMSTANCES. THE FOUNDATION HAS TEAMED UP WITH TWO PLATES, A BENEFIT CORPORATION, TO PROVIDE MEALS TO ECONOMICALLY VULNERABLE FAMILIES WITH NEWBORNS IN ARLINGTON, VA. THROUGH THIS PROGRAM WE HAVE BEEN ABLE TO FEED THE UNDERSERVED WHILE HELPING TO GET UNEMPLOYED KITCHEN STAFF BACK TO WORK. OUR PARTNER RESTAURANT GROUP LEBANESE TAVERNA GROUP HAS DONATED KITCHEN SPACE AND OTHER RESOURCES.
