### **Form 990, Part III, Line 4a:**

In 2020, the Cancer Prevention Initiative (CPI) programs have progressed and CPI continues to grow and develop. Despite some timeline adjustments made necessary by COVID-19 related delays, CPI's research grant recipients have continued to advance us towards understanding and preventing inherited cancers. A new project at Harvard's Beth Israel Deaconess Medical Center is working to identify cancer risk predictors in the mammary epithelium on BRCA mutation carriers. Another project at City of Hope was funded to further progress repurposing a safe, FDA approved anti-parasitic drug that has great promise for reducing breast cancer growth. Repurposing drugs is a safe way to bring therapies to patients quickly. Related to this is a need for ways to evaluate known drugs for new purposes. A team at the University of Toronto is developing a test to screen for drugs that can restore normal BRCA1 function to BRCA1 deficient cells. An international collaboration has co-developed a candidate vaccine for the prevention of triple negative breast cancers in patients who have inherited a BRCA1 mutation. They are now testing their vaccine candidate in preclinical models, which will provide us with results in 2021.

Education and community engagement programs: In 2020, CPI launched a new website that includes highlights of new progress in the cancer prevention field that is relevant to a broad audience. As we move closer to our goal of eradicating all cancers through preventative medicines, we believe that educating the public and raising awareness about inherited cancer syndromes will inspire more individuals to take proactive, life-saving preventive measures. One of the goals is to enhance the scientific reach of the organization and raise awareness on cancer prevention to a broader audience of patients, advocates and donors. Thus, regular updates on scientific and medical research advances, recent clinical trials, and interviews with experts in cancer prevention are published on web-based platforms.
