

Line 10: A total of \$44,545.69 was provided to Friends of Hoja Nuevas official Peruvian sister organization, Hoja Nuova, in the form of grants.

Said grants were either withdrawn as cash and personally transported to Peru by officers, or transfered to Peru.

Funds transferred to Peru were done so either by means of international transfer services or direct wire transfers to bank accounts.

Recipients of direct wire transfers to bank account in Peru were exclusively service providers.

Recipients of international transfer service transfers were officers in Peru.

All funds transfered to Peru were directly allocated to the continued goal of wildlife rescue & rehabilitation in Peru through Hoja Nueva.

Hoja Nueva is comprised of volunteer team members and has minimal administrative costs.

As such, over 90% of funds transferred were applied to program service expenses in Peru. The remainder was applied to administration.

Line 16: A total of \$19,482.07 was allocated to the purchase of equipment for the continued goal of wildlife rescue & rehabilitation in Peru.

Hoja Nueva requires certain specialized equipment not available for purchase in Peru.

Friends of Hoja Nueva purchases said equipment in the United States and transports or ships it to Peru.

All equipment purchases were made through the organizations credit card.
