Crisis Intervention - Chance Shelter continues to provide our resources through alliances with Banner Del Webb and Banner Boswell social workers to foster pets while their owners were in crisis situations. We also assisted with some referrals from funeral homes and care facilities for pets needing to be adopted due to the owner's passing with no next of kin available to care for the pets. We continue to assist Surprise Animal Care and Control with pets that are available to be adopted. We operated strictly with our fosters and the help of volunteers, as we do not have a facility yet. We continue to expand our foster and volunteer lists to accommodate more pets. In 2020, we cared for 50 animals in crisis situations. Of these, 17 were medical emergencies where the pets needed either permanent or temporary placement resulting in a total cost savings of over \$6,500 in boarding for the owners. This is based on a total of 209 days of boarding between all pets and includes supplies costs. Some of these pets were repeat visitors as thier owners were in and out of hospital care. We also provided some financial assistance for pet owners who could not afford the veterinary bill for their ill pet. Chance Shelter also provided rehoming assistance for 5 pets by way of a courtesy posting on our social media page and offering guidance in the steps necessary to rehome a pet. We were able to continue our adoptions by adhering to CDC gudelines and taking extra precautions on our part.

Form 990, Part III, Line 4b:

Community Outreach & Volunteer Program - Chance Shelter has been a strong part of many community outreach events. Pre-COVID, we participated in over 11 events, several presentations, and many meetings resulting in reaching over 3,300 citizens in the first 3 months of the 2020 year. These events included: open houses at local fire stations, community outreach events, pet care/awareness classes for children and adults, presentations at local recreation and dog clubs, sporting events, and fundraisers. We continued to offer pet CPR and first aid classes to both the public and our volunteers until we were shut down in the middle of March. During these events we were able to expand our presentations through invitations from local businesses and outreach groups which has helped to increase our number of fosters and volunteers. Despite the pandemic, we were able to increase our foster and volunteer numbers through Zoom interviews and virtual home evaluations. Our remaining meetings, presentations and any other events took place via Zoom and when in person, adhered to CDC guidelines.
