ADOPTUSKIDS FAMILY SUPPORT TEAM - DURING 2020, NACAC PROVIDED TRAINING TO MORE THAN 1,000 MEMBERS OF THE ADOPTION, FOSTER CARE, AND KINSHIP CARE COMMUNITY ABOUT THE VALUE OF PROVIDING SUPPORT, HOW TO ASSESS FAMILIES' NEEDS, AND MODEL PROGRAMS SUPPORTING CHILDREN AND THEIR FAMILIES. IN ADDITION, WE DEVELOPED RESOURCES ON THE VALUE OF SUPPORTING ADOPTIVE, FOSTER, AND KINSHIP FAMILIES AND VARIOUS WAYS JURISDICTIONS CAN PROVIDE THIS SUPPORT.
