NLS MEDICAL LEGAL PARTNERSHIPS: NEIGHBORHOOD LEGAL SERVICES PARTNERS WITH EVERGREEN HEALTH, ROSWELL PARK COMPREHENSIVE CARE CENTER AND THE VETERANS ADMINISTRATION TO PROVIDE LEGAL SERVICES TO PATIENTS. THROUGH THE MEDICAL LEGAL PARTNERSHIP MODEL, NLS ADDRESSES THE MOST PRESSING HEALTH HARMING LEGAL NEEDS OF LOW INCOME CLIENTS AND TRAINS LOCAL MEDICAL PROVIDERS HOW TO SCREEN FOR A RANGE OF STRUCTURAL DETERMINANTS AND CONDITIONS IN WHICH PEOPLE LIVE (HOUSING, UTILITIES, INCOME AND HEALTH INSURANCE) THAT IMPACT HEALTH. NAVIGATORS PREPARE APPLICATIONS FOR THE CLIENT, ELIMINATING THE STRESS AND CONFUSION CAUSED BY COMPLICATED REPORTING REQUIREMENTS, ID AND INCOME PROOFING AND TAX CREDIT REQUIREMENTS. CLIENTS ARE ENROLLED IN MEDICAID, CHILD HEALTH PLUS AND PRIVATE INSURANCE PROGRAMS ACCORDING TO INCOME ELIGIBILITY AND ARE ALSO ASSISTED WITH ANNUAL RENEWAL REQUIREMENTS. NLS UTILITY DISCONNECT HOTLINE: IN PARTNERSHIP WITH NATIONAL FUEL, NLS ADVOCATES ASSIST INDIVIDUALS WHO HAVE HAD THEIR UTILITIES DISCONNECTED OR RECEIVED UTILITY DISCONNECT NOTICES BY PROVIDING FREE INFORMATION, REFERRALS, ADVICE AND REPRESENTATION. INDIVIDUALS WHO HAVE BEEN IMPROPERLY DENIED HOME ENERGY ASSISTANCE PROGRAM (HEAP) BENEFITS CAN ALSO BE HELPED.
