cost pre-hospital emergency care and emergency ambulance transportation for residents of Belt and eastern Cascade County, Montana.

Part 3; Achievements: During 2020, Belt ambulance (BVAS) provided medical care to over 150 residents of our area and surrounding areas.

BVAS provided EMT training classes to county first responders. These classes resulted in 8 newly licensed EMTs for our service area.

Continuing education classes were provided for all AEMT / EMT/ EMR personnel in Cascade County.
