Increased emphasis has been placed on local empowerment as travel to Kenya has been impossible this year. Technology has helped to continue in our commitment to build sustainability and indigenous replication capacities.

In Tanzania, Teleios Ministry provided material and human resource assistance in support of the education and welfare of orphans and vulnerable children. This included primary support for the operation of two childrens homes and the affiliated programs associated with those institutions. Grants were made to help alumni of the childrens homes to open small businesses after finishing their education. These entrepreneurs are learning to operate successful businesses while donating a portion of their profits back to the childrens homes, investing in the future of children there. This type of long-term self-sustainability has been a great concern. Vital to these efforts are the provision of both training and mentorship services. This is a focus that is in the beginning, planning stages at years end. As in Kenya, staff did not travel to Tanzania this year physically, but were able to communicate consistently using technology in order to oversee the

Teleios Services is an organization owned by two of the directors of Teleios Ministry, and the company bills certain employers for the costs of providing these chaplains in their workplace environment. Teleios Services receives per employee payments and pays Teleios Ministry an amount to reimburse the organization for actual costs. The risk of loss in these transactions thereby remains with Teleios Services.
