The Organization approaches easement violations and non-compliance by comprehensively analyzing all aspects of the easement and taking into consideration other facts and circumstances.

PART II, LINE 9:	The Organization received all of its easements via donation. The Organization does not report donated easements as revenues or as assets. The footnotes to the Organization's financial statements include the following related to conservation easements: "Property owners grant to the Corporation conservation easements that restrict the owner's use of the land in perpetuity. Some allow the Corporation to conduct research and studies on the properties. At December 31, 2020 the Corporation held easements on six properties for a total of 731 acres. Since the Corporation does not receive any rights to the property, the Corporation does not report a value."

PART XIII:	Conservation Florida records lands conserved at cost if purchased or at fair value at the date of acquisition if all or part of the land was received as a donation. Fair value is estimated with reference to appraisals, taxed assessed value and other pertinent information gathered at the time of acquisition and is not subsequently adjusted. Conserved land is real property with significant ecological, recreational, scenic, or historical value. These properties are managed in an effort to protect the natural biological diversity of the property. Donated properties are often subject to certain conditions, covenants and reversionary clauses that prohibit the sale and restrict the use of the properties. For this reason, these properties are reflected in donor restricted net assets. At December 31, 2020, the Corporation held one property for a total of 476 acres.
