Cor Jesu collects, Purchases, sorts, packages and distributes food to the needy at its facility located on South Hopkins Avenue in Titusville. Schedule M, Part I, Line 19	Non-Cash donations are food items and/or personal hygiene supplies. During holidays we receive lots of toys and stuffed animals. Food products are our major source of donations. Donations are received: 1) Food is brought to our facility; 2) Various food drives during the year contribute to the facility; 3) Some churches regularly collect food and bring it to us, others have periodic drives and also bring food to us; 4) Schools, clubs, civic groups and other organizations periodically collect food or have food drives. Value of food products is determined by matching typical assortment and quantity of food received and pricing it periodically at local food markets. Food is packaged to provide a balanced diet and is based on the number of members in the family or other unit being fed. Perishable items are received weekly or purchased at a reasonable price at Second Harvest Food Bank. Eggs and butter are purchased locally to add to the assortment. Most donated items are boxed or canned. We have several refrigerators and freezers to store perishable items. Our inventory turns over quickly. Our actual number of donors exceeds 1000 as many bring to churches and other collection sites before we receive the goods.
