ANOTHER COMPONENT OF THE JOB COACH IS TO ALSO HELP WITH INTERPERSONAL SKILLS THAT ARE NECESSARY IN THE WORKPLACE. THE JOB COACH IS ESPECIALLY HELPFUL FOR THOSE INDIVIDUALS WHO MAY HAVE MORE SIGNIFICANT CHALLENGES, BUT WITH THE RIGHT TRAINING THEY ARE ABLE TO HELP DISCOVER, STRENGTHEN, AND SUPPORT NECESSARY SKILLS AND THE NEEDS OF THAT PARTICULAR STUDENT.
