Part I Line 2	For U.S. Donors, Partners and Grantors, Missio International maintains oversight and exercises expenditure responsibility for our Romanian Ministry Partners Grantees operations and programs. Our Romanian Ministry Partners provide Missio International with quarterly narrative program reports and monthly YTD financial reports. As least once a year, the Missio International President and or a member of the executive team, each of whom is a Missio International Board Member, visit Romania for ministry meetings and to personally observe all ministry programs. These board members observe our Romanian Ministry partners programs and provide periodic reports to the Missio International Board. Each year, these board members spend at least two weeks in Romania observing program operations and progress. These visits include interviewing the Romanian ministry staff, program beneficiaries, and independent advisors. Due to travel restrictions related to the COVID-19 pandemic, no travel was conducted in 2020 and the frequency of contact was increased through video conferencing. The Missio International President and one other Missio Director both serve on the Board of Directors of MLI, our major ministry partner. In addition, the President of MLI serves on the Board of Missio International. Additionally, both by email, cell, and ZOOM conference calls, the President of MLI and the Executive Director of MLI keep Missio International updated on operations, staff issues, and program progress. These oversight conference calls and field visits in Romania augment the monthly, quarterly and annual financial narrative reporting received by Missio International from our Romanian Ministry Partners. In addition to the formal site visits mentioned above, various Missio Board Members make personal visits to our partners in Romania each year.
