Form 990 – EZ, Part III, Line 28 – First Accomplishment

Classes: NW Dance Network offered Winter 2020 classes for a variety of traditional social dances. The classes were open to the public

(singles, couples, all ages and abilities), widely publicized and held in a non-competitive group setting. Instructors

were highly skilled and carefully trained. More experienced dancers volunteered during classes to assist the instructors.

Tuition was kept low to make the classes affordable to many. Due to Covid-19, all in-person classes were suspended in March, 2020.

Form 990 – EZ, Part III, Line 29 – Second Accomplishment

Community Dances: NW Dance Network offered community dances twice per month. Dances were widely publicized, open to the public

(singles, couples, all ages and abilities), and included live music. The dances were smoke-free and alcohol free. NDN supported local

musicians and promoted local artists. Attendance price was low so they were very affordable.

Due to Covid-19, all in-person dances were suspended in March, 2020.

On-Line Workshops: With no in-person activities allowed, NDN presented on-line workshops of many types and styles of dance. A total

of 70 workshops were presented via ZOOM. The cost to attend any of the workshops was "pay as you wish", this allowed participants to

attend even if they were unable to pay. This program was a departure from prior and began May 28, 2020. It was an incredible effort by

instructors and staff to move to a totally different delivery of dance to the public. The workshops were well received and greatly

appreciated by the dance community. The annual dance camp at Seabeck was not held in 2020.
