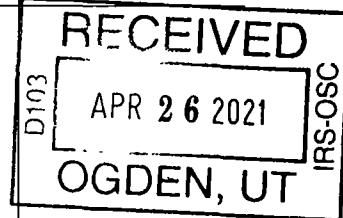



Part III, line 31 Partnering for the Holidays--This program helps low-income families in crisis by offering financial and emotional support to prevent homelessness and provide family stability. 2020 program grants \$10,240 and expenses \$6,072.

Part III, line 31 Family Leadership Training Institute provides parents/youth/communities with the knowledge, skills, and tools they need for effective civic leadership. The goals of FLTI are to effect positive social change. 2020 grants \$10,000 and expenses \$2,115.

Part III, line 31 Sr Citizens Emergency Fund established in 2018 to support senior citizens who were displaced by fire. This program was designed to assist with security deposits and other rental requirements for eligible residents. 2020 grants \$0.00 and expenses \$2,436.

Part III, line 31 Collaborative Foster Care is committed to assuring foster parents have adequate training, support, and resources to promote the child's best interest. 2020 grants \$3,100 and expenses \$2,008.

Part III, line 31 Pre-Trial Navigator--this program is to reduce the harm imparted on defendants with behavioral health disorders do to pretrial jail confinement and repeated entanglement with the criminal justice system. 2020 grants \$0.00 and expenses \$1,322.

Part III, line 31 Colorado Master Gardener Program, a dedicated group of 75 Colorado Master Gardener (CMG) volunteers serve nearly 650,000 residents annually through answering yard, garden, and insect questions. We provide Colorado State University research-based information to help with all gardening challenges and questions. 2020 program grants \$0.00 and expenses \$118.
