The clothing is also available for much-reduced, affordable prices to the public to support the expenses associate with the program as well as to provide a great source of professional wear for those who have little extra to spend on attire or who are the keen on saving dollars while supporting a great cause and getting wonderful career wear. Recipients of free services are low income Arizona residents referred through partner social service agencies; customers come from all walks of life including discerning shoppers.
