The festival encompassed 29 events including short and feature film screenings, panel discussions, performance, live presentations. The film program consisted of 80 films from 30 countries.This years 13th edition will be fully online due to the current world crisis were living in. It was critical nevertheless for Imagine Science to have the festival as were committed to communicating science, especially in a time where facts can easily be distorted through media channels causing misunderstandings, fears, and anger in our world. People crave to understand scientific facts and stories around how our cultures and societies are intimately linked to science.
