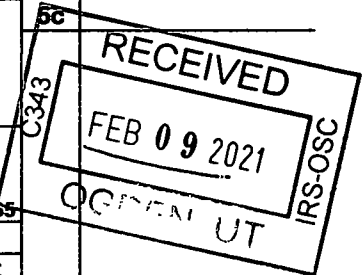

Part 1 - Line 12: In 2020 Tim and Dar Ratzloff, the executive directors of Jumaph.org, continued as staff employees for Mountain View Community Church as in proceeding years. They worked exclusively for Jumaph.org in advancing its program goals. The expense listed on line 12 is what Jumaph.org reimbursed Mountain View Community Church for Ratzloff's compensation and employer related taxes for the entire year of 2020.

Part 1 - Line 16: other costs include \$10,843 for office supplies, accounting software, licenses & fees, banking fees, and internet promotion costs. This amount also includes partial reimbursement for the executive director's travel costs to Cambodia to inspect the project and to advise and encourage the leadership and staff engaged in the program work in Cambodia.

Part III - Line 28: JUMPAH SCHOOL - Jumaph partially funded the operational costs (teacher salaries, school supplies, facility expenses, etc) of the Jumaph School that provided a high quality and loving education to children from nine neighboring rural villages.

The Jumaph School is a private Cambodian government accredited school offering classes pre school through sixth grade to children that otherwise have little opportunity to receive even a basic education (reading, writing, math, etc.) in the local "public" schools. The enrollment totaled over 400 students at the beginning of 2020. Then the government closed all schools due to the Covid 19 pandemic for much of the year. In the fall of 2020 the school reopened at partial capacity per government mandate with an enrollment of about 220. Each family pays about \$15 per per month. Jumaph.org in the US funds the balance of the school's operating costs.

Part III - Line 28: WOOD SHOP & FARM - Jumaph.org also provided funds to develop the vocational training & employment for at least 8 local villagers at the wood shop. Jumaph also funded the expansion of a model farm that demonstrates economical methods in successfully raising a variety of vegetable crops to supplement their single crop of rice. The farm employed about 8 local residents.

Jumaph.org transferred the above funds through a Cambodian government licensed non-profit local NGO (non-government organization) under the same name "Jumaph".

Part IV regarding Tim & Dar Ratzloff's activity: Though the Ratzloffs served as Executive Directors for Jumaph.org, they continued to work directly with the Jumaph program both at the project site in Cambodia and from their office in the US. They acted as consultants giving direction and advice to the leadership and staff in Cambodia as they have for past several years.

Part IV regarding Tim & Kristine Scoville, in past years they have spent several weeks in Cambodia assisting in development of the wood shop worker skills as well as assisting the school with teaching materials and facility improvements. In 2020 they did not travel due to

Covid-19 travel restrictions.
