COVID-19 was the major cause that put the T. Thomas Cultural Center on pause from March, 2020 until August 21, 2020, when the Cultural Center hosted its very first Facebook Live event in celebration of Count Basie's birthday. We had been preparing to open our Count Basie exhibit and then COVID-19 rearranged everything. We suffered a loss of funds from dated marketing materials to advertise the exhibit to withdrawing our contract with the caterer. However, on September 25, 2020, we were able to finally open the highly anticipated new exhibit: "A Love Letter to Count Basie: From the Great Migration to the Harlem Renaissance." It had been put on hold for seven months due to the pandemic. However, with strict safety protocols, the Cultural Center opened the exhibit to great fanfare. The reception as held on the front lawn of the Cultural Center for safety, while small groups of 5-6 people, all of whom were masked, were escorted into the Fortune Cultural Center, to view the exhibit. To stay connected to our patrons the Cultural Center transitioned to virtual online program events, such as the Women-In-Media Film Festival in October that explored stories told by filmmakers of the African Diaspora. Before the pandemic, the Film Festival had been scheduled to be held in April, when the country was on total lockdown. The online event promoted by Women-In-Media and the Cultural Center attracted a large viewing audience. We reignited our book club and we met monthly to discuss the book *Caste*, by Isabel Wilkerson. In November, we opened the doors of the Cultural Center for a Black Friday vendor shopping event that was held from noon to 4:00 pm, with everyone having to wear a mask in the building. It proved to be a success in attracting vendors and patrons. The Cultural Center followed that up with a Facebook Live event in December, titled: *Reimagining the Police*, which received over 3,000 reviews, the power of social media proved to be a force in us keeping in touch with our audience and patrons. Partnering with Two River Theater in Red Bank, the T. Thomas Fortune Cultural Center presented an online professional development workshop for teachers - *The Art of Social Justice* - linking the arts and the T. Thomas Fortune Cultural Center's mission of advocating for social justice together. We had teachers join this virtual event from all over the state of New Jersey and there was a teacher who logged on from the Mid-West. Throughout the pandemic, we've been successful in bringing up-to-date information to our patrons through our widely read Noteworthy newsletter. It has been beneficial in keeping the Cultural Center connected to donors, patrons, corporations, and nonprofits, alike. Our innovative efforts to stay in contact with our audience attracted new patrons despite the COVID-19 challenges we faced. Indeed, we are grateful.
