In 2020 we closed for 5 months due to Covid. We continued to prepare meals, serve, deliver, plus curbside pickup twice a week. We served 3,345 meals compared to 2019 at 2,437. Attendance dropped for health & fitness, games, socialization and education classes. Members and non-members can attend any of our activities. Health & Fitness classes had 1,837 attendee occurrences. During the months of closure we looked for more grant opportunitites which we were sucessful to receive. This helped to sustain our operations because we were unable to have our traditional fundraisers.
