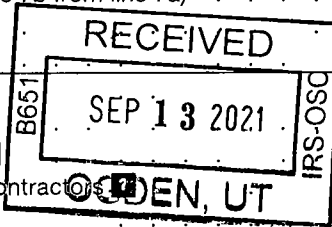

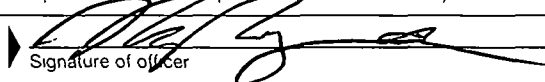

The purpose of this filing is to request the 'name change' of this existing 501c(3) organization, classified 509a(2). Currently, the name of this organization is DylanListed Connect. Attached, I've provided a letter signed by the Founder, President and Chairman of the organization stating that on July 31st, 2020, the former DylanListed Connect executive board approved to adopt the name change to North Texas Disability Chamber. I also submitted the admendment changes with the Texas Comptroller, and provided the attachments, including, the Certificate of Filing and the Exemption Verification Letter with the new name change (North Texas Disability Chamber) in Texas. Additionally, I have also included the new effective and updated North Texas Disability Chamber ByLaws. The only changes that have been made are updating the organization name, onboarded new board members, and changed the name of registered agent. The rest has of the organization's ByLaws have not changed. The organization's mission and vision stays the same.

In early 2021, we have filed the 990-N (e-postcard) without realizing we could have posted the name change there. We also sent on two occasions sent two different letters requesting the name change while providing requested documentation and have not heard back. This is what led us to draft these documents. There is nothing new to report other than updated documents and a name change.

Part V - As previously stated, the purpose of this filing is to submit a name change for this existing nonprofit organization. The name change will be North Texas Disability Chamber. I have provided the letter that I submitted with documentation that has previously been done with the State of Texas Comptroller including updating the existing ByLaws with the name change, new board members, and its new registered agent.
