

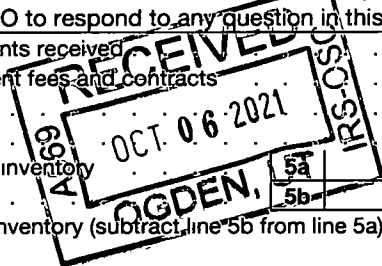

FROM 990-EZ, LINE 8 (other revenue):

We were refunded a grant of \$ 15,000 that we had given to a partner organization, Friends of Maasai Mara, in 2018. The refund was made by a member of their board.

The other \$ 100 was an honorarium given to the OliveSeed executive director by Stanford Business School for a student interview.

FROM 990-EZ, LINE 16 (other expenses):

These are overhead expenses other than printing and shipping costs. They are primarily software, web domain fees, web hosting fees, a PO box, fees for annual charity registrations, and office supplies.

FROM 990-EZ, PART III (top three programs in 2020):

1) COVID-19 RELIEF INITIATIVE (§ 13,359):

a) Food Relief: From April through October 2020, we fundraised for, supported, and managed a COVID-19 relief program in the Maasai Mara region of Kenya. Working with teams on the ground, we provided food on an ongoing basis for over 400 of the most vulnerable families.

b) Healthcare Support: We partnered with a sewing cooperative in Kenya to buy hundreds of masks for residents in the Maasai Mara. We then worked with the local clinic in Aitong, Kenya, to deliver masks, soaps, and educational information about the pandemic to families along with their food items and to others in the community.

2) MOROCCO LIBRARY PROJECT (§ 15,271):

a) School Libraries: This is one of our long-term programs. In 2020, we curated and supplied books for two new high school libraries in rural Morocco and supplemented other libraries in our network here. The two new libraries will benefit 2000 English learners.

b) Writing Competition: We held a nationwide Short Story Competition for high school students throughout Morocco. As part of this, we gave e-readers to the winning writers and provided books to all participants and their schools. We managed the judging and coordination of this competition with our team members in Morocco, and in the end we published an ebook anthology of the stories.

3) MAASAI MARA COMMUNITY DEVELOPMENT (§ 17,417):

a) Mara Discovery Center: We renovated the only community center in this region of the Maasai Mara. In addition to extensively remodeling the building inside and out, we developed a wildlife and children's library, added a tree nursery and tool shed, and upgraded the IT
