



1) obtained a completed set of engineering drawings to construct Town Creek Trail as a handicap-accessible route,

2) applied for and received funded grants of \$102,500 plus grant funding commitments totaling \$77,500 for construction of the trail and a

connecting sidewalk, and

3) received a commitment from the City of Trenton to construct a signalled crosswalk on Main Street for safe pedestrian crossing between

Jenkins Park and its Town Creek Trail extension.

The Town Creek Trail project builds upon foundational programs the organization completed and paid for in 2018 and 2019, including a

tourism study (which called for more pedestrian friendly areas in Trenton) and a report compiled by the University of Georgia advocating

restoration of native plant species in Trenton's historic downtown.

Persons Benefitted: The Town Creek Trail project is designed to benefit residents of Trenton (population 2,300) and surrounding Dade

County (population 16,400), and the area's nascent eco-tourism industry. The organization believes that tourism benefits from pedestrian-

friendly communities, and tourism in turn benefits the local economy.
