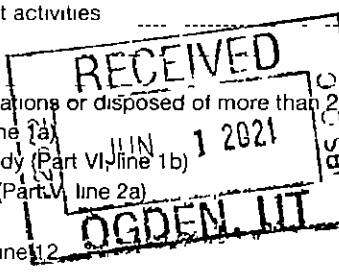

The Digital Integrators is a workforce model to be piloted in select US markets in 2021. Pilots will demonstrate the potential for tech-enabled human capital approaches to expand economic opportunity by connecting people to digital skills and employment. We are also building local partnerships to stand up Digital Advancement Alliances that adopt and implement our Digital Advancement principles and policy recommendations. Centri Tech Foundation initiated the design of policy activities to promote digital advancement for municipalities, including: a series of engagements in spring 2021 with municipal leaders to discuss digital advancement strategies; and a prototype for a municipal index for digital advancement. Centri Tech Foundation engaged in educational activities with policy leaders to present on its work and the Digital Advancement principles.

The Technology Adoption Program was established to create a useful technology capacity program for the affordable housing industry including affordable access to broadband and relevant technology for low-income residents. Centri Tech Foundation's program work sought to demonstrate the programmatic and economic viability of life-enhancing technology enabled initiatives with the larger goal of creating a de-facto technology standard for affordable housing. Engagement with local stakeholders in 2020 included municipalities and local communities seeking to address digital equity and inclusion, such as public housing authorities, housing developers, statewide broadband coalitions, community development groups, library systems, Historically Black Colleges and Universities, nonprofit organizations, and workforce development groups.
