Reason for filing late. At about 7:55 am on November 15, 2021 I was working on my desktop computer to complete the Form 990-EZ for submission *hted*

The Franklin Public Utility District power failed and was not restored until about 10:00 am and affected about 6,000 customers. When power was *ra*

restored my desktop computer was broken. I called my computer repair contact who agreed to come work on it when he finished the task he was on.

When the repairman arrived he quickly determined that the power supply on the computer had failed, probably from a power surge when power

was restored. He installed a new power supply in the computer. By the time the computer was back up and running, there was not sufficient time

to complete the changes to the return and meet the November 15 due date.
