**Part V- Line 34- The City of Lenexa City Council passed Ordinance No. 5795 which modified the Foundation's governing documents to clarify and provide additional guidance regarding the acceptance of contributions, gifts, and donations and to only require one board meeting annually. In addition, The Foundation Board approved Resolution LF2020-01 which combined three existing policies into one individual policy and established additional guidance and controls related to fundraising efforts by the Foundation and relationships between the Foundation and current and prospective donors.**
