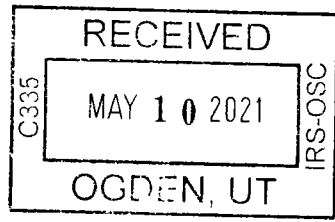



Part III Statement of Program Service Accomplishments

Line 28: (1)We provided a grant to 3 ANGELS NEPAL fully funding (100%) the operation of the Women's Safe Haven program in 2020. This program gave short to medium term aftercare support,counseling,and accommodation to 60 victims of human trafficking throughout the year.

(2) We provided a grant to the 3 ANGELS NEPAL MY BUSINESS - MY FREEDOM Microfinance program. This provided loan capital to the program enabling 15 women to join the program and receive training, advice on setting up a business, and a small business loan.

Line 29: Western China Vocational School Scholarship support .We enabled 80 girls to start attending, or remain in their 3 year Vocational Training program. This program locates girls in remote locations of Western China,who have already dropped out of school,and opens up new opportunities to keep their education dreams alive.

Line 30: The Captivating Pigs for Poverty Program. This program helped 125 women from remote village locations in Western China start their own piglet business. Each women was provided two breeding sows, training and follow-up support.

Line 31: Tiny Hands .We provided a grant to TINY HANDS NEPAL supporting the operating costs of 5 monitoring stations on the indo-Nepal border. Due to COVID 19, these stations only remained open Jan-Mar 2020. During this time, 72 women were intercepted/stopped showing high-risk factors indicating they were likely in the very process of being trafficked into India. Following the temporary closure of the monitoring stations due to the Nepal border being shut, the staff of these 5 monitoring stations turned their attention to providing emergency food relief and support to starving families who had lost their jobs, with 3,086 people receiving emergency food packs.
