LEAD Academies Financial Support - LEAD Africa academies combine high-quality education, professional sport training, good nutrition, healthcare, and life skills to empower future leaders. In 2020 LEAD made grants to two academies LEAD Monrovia Football Academy in Monrovia, Liberia (est. 2015) and LEAD Morocco in El Mansouria, Benslimane, Morocco (est. 2019). LEAD Africa provided \$342,814 of financial support to LEAD Monrovia Football Academy and \$123,835 to LEAD Morocco.
