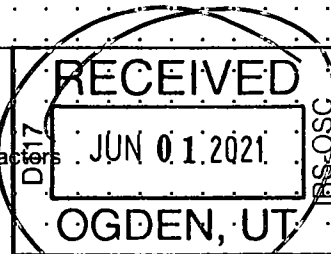

Scholarship Selection Process:

The Foundation recognizes students for their academic achievements, community service & involvement, leadership skills etc. Only students in good standing at their respective high schools are eligible. Relevant information about the students is verified with their high schools. Based on an established process (similar to the admissions process used by the nation's military academies), the Foundation scores students on a written essay, their GPA, extra-curricular activities, community service, public speaking skills, and in-person interviews. Points are awarded for each established category. The point categories are tallied and the scholarships are awarded based on their respective point total ranking. The students are awarded scholarships when they provide proof that they are enrolled in a college or university of their choosing. All scholarships are merit based scholarships as described above. Eligible students are high school seniors attending one of the areas/regions 12 high schools. The faculty and staff of the area high schools select the students their school refers to the Foundation to be considered for a scholarship. The student with the highest ranking point total receives the largest scholarship with lesser amounts going to the next lower point total student. During 2020, 19 area/regional students shared in a total of \$35,000 in scholarships and represented high schools in western New Mexico and eastern Arizona.

Additional information - Senior of the Month Program

Each month area high schools select their outstanding "Senior of the Month" who, along with their faculty advisor, are invited to attend a luncheon to honor the selected "Seniors of the Month". The foundation only pays for the meal of the outstanding senior and their faculty advisor. All others attending the meeting pay for the cost of their own meal. During the luncheon the senior gives a 2-3 minute talk on their current activities and future plans. Their talk is graded and becomes part of the score used to determine the amount of the scholarship that the student might receive when scholarships are awarded as part of the selection process described above.
