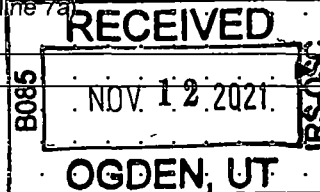



Reasonable Cause Explanations

Explanation

For the year ended 12/31/2020, due to a lack of understanding of the filing requirements by the volunteer management and directors, the Association was unaware of the filing requirements. The Association was not deliberately neglecting its filing requirement. Had the Association been informed earlier that it had a filing requirement, the Association could have had the opportunity to address its failure to be in compliance. None of the directors had any reason to deliberately fail to file a return. As soon as the current directors learned of the revocation, they immediately began preparing the unfiled returns to bring the organization current. We believe this conforms to the "ordinary business care and prudence" criteria expressed in Rev Proc 2014-11 which states that reasonable cause may be found when an organization demonstrates that it "acted in a responsible manner by acting as promptly as possible to correct the cause of the reporting failure once the failure was discovered. We believe this is an appropriate criterion, since an organization cannot be expected to correct a mistake before it has been discovered."
