Azimuth World Foundation was formed in 2019 to actively participate in creating a world where humanity and nature thrive by elevating and supporting other nonprofit organizations actively working to address root-causes in social, environmental and nature conservation. Azimuth World Foundation continues to be in start-up mode due to the global pandemic for COVID-19. Azimuth gives voice to and raises funds for charities that implement solutions that change the world in a positive way in three key areas: *Public Health because diseases can be prevented or treated with timely access to appropriate and affordable medication and other health services. *Access to Safe Water because it means life, health, education, and income especially for children and women, yet 2.1 billion people still live without clean and safe water. *Balance between Humankind and Nature because we need to build on successful conservation efforts and help local communities find ways to thrive alongside nature and wildlife. During 2020, Azimuth partnered with Water Missions International on two safe water projects. With the installation of 30 handwashing stations at 15 schools in Kasulu district, Tanzania, the organization provided access to safe water for 23,337 children, teachers, and their families. In addition, this partnership helped to implement a brand new safe water system at a Malawian Health Centre in Mzimba district, serving 19,600 people. The Centre had been operating without safe water since February 2020 when an on-site water pump broke. This impact, added to the pandemic's social consequences, forced Azimuth World Foundation to readjust its fundraising strategy and calendar . Even though Azimuth's fundraising strategy was significantly based on online fundraising through its website and social media, Azimuth was still just getting ready to launch its website's design and development when the pandemic hit. The pandemic's unexpectedness forced the freelance web developers (who had already been hired to do the website's development) to readjust their work schedule, seen as most of their business urgently required a more substantial online presence. Similarly, the web designer was also faced with the same problem, leading to a significant, unintended delay to Azimuth's website development. Additionally, many meetings were either postponed or delayed because safeguarding the well-being of staff, donors, partners, and other stakeholders was obviously the priority, and the necessary digital adaptations were not yet in place. Both our team and board also required some time to adjust appropriately to a remote work environment. The pandemic's financial implications added to the aforementioned unforeseen challenges forced us to re-evaluate our fundraising strategy and goals. This reassessment was frequently revised and altered due to the unpredictable nature of the events that unfolded in 2020's last quarter. Moreover, the evident need to prepare for the financial implications meant creating a plan to help Azimuth's team get into a leaner management mode. These circumstances significantly impacted the Foundation's business plan and strategy and meant a substantial delay in launching fundraising campaigns.
