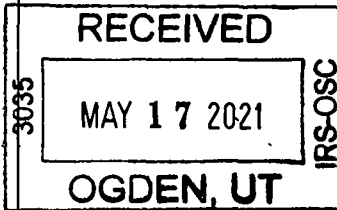

ARTICLES OF AGREEMENT OF A NEW HAMPSHIRE NONPROFIT CORPORATION

THE UNDERSIGNED, BEING PERSONS OF LAWFUL AGE, ASSOCIATE UNDER THE PROVISIONS OF THE NEW HAMPSHIRE REVISED STATUTES ANNOTATED, CHAPTER 292 BY THE FOLLOWING ARTICLES:

FIRST: The name of the corporation shall be:

~~Friends of the Northern Rail Trail in Merrimack County~~

SECOND: The objectives for which this corporation is established are:

A. To assist in the provision and care of the publicly owned Northern Rail corridor in Merrimack County as a multi-use transportation and recreation rail trail in cooperation with the State of New Hampshire, local municipalities, and other interested groups and individuals;

B. To promote the public use of that recreational rail trail;

C. To raise money and encourage volunteers to accomplish these objectives in a manner not inconsistent with the provisions of Section 501(c)(3) of the Internal Revenue Code of 1986 (as from time to time amended, the Code) or corresponding provisions of any subsequent federal tax laws; and

D. Any other object for which an organization may be exempt from federal taxation under Section 501(c)(3) of the Code, including for such purposes, the making of distributions to organizations that qualify as exempt organizations under that Section.

THIRD: Limitations on Actions:

A. No part of the net earnings of the corporation shall inure to the benefit of or be distributable to its members, directors, officers, or other private persons or organizations, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in these Articles of Agreement.

B. No substantial part of the activities of the corporation shall be carrying on propaganda or otherwise attempting to influence legislation (except as otherwise provided by Section 501(h) of the Code) and the corporation shall not participate in or intervene in (including

the publication or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

C. Notwithstanding any other provision of these Articles of Agreement, the corporation shall not carry on (i) any activities not permitted to be carried on by a corporation exempt from federal income tax under Section 501(c)(3) of the Code or (ii) any activities not permitted by a corporation, contributions to which are deductible under Section 170(c)(2) of the Code.

FOURTH: The provisions for establishing membership and participation in the corporation are:

Until such time as By-laws are adopted and provide otherwise, the incorporators shall be the members of the corporation and a majority of the incorporators shall possess all of the powers of the corporation; thereafter the provision regarding membership and participation in the corporation shall be as set out in the By-laws as adopted by the incorporators, and as they may be amended from time to time.

FIFTH: The provisions for disposition of the corporate assets in the event of dissolution of the corporation including the prioritization of rights of shareholders and members to corporate assets are:

Upon dissolution of the corporation, the Board of Directors, after paying or making provision for the payment of all of the liabilities of the corporation, shall dispose of the assets of the corporation by distributing them to one or more charitable or governmental organizations which are exempt from federal income tax under Section 501(c)(3) of the Code.
