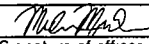

Then, they receive personalized career coaching, resume and cover letter help, and connections to future employers. In 2020, the Organization recruited, trained, coached and supported more than 120 fellows, 65% of which were people of color and 69% women or non-binary people.

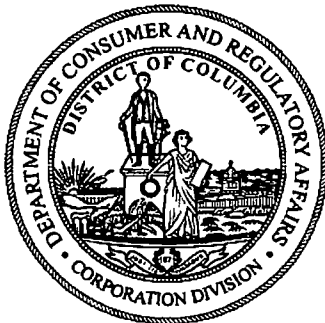
