28 Due to the pandemic in 2020, Deep Heart's primary program became the publication and distribution of a full-color magazine, Deep Heart UNBOUND. Written specifically for the incarcerated population, UNBOUND combines the visual arts with inspirational themes, in order to combat mental atrophy, stimulate creative and critical thinking, encourage discourse, and inspire positive personal development. The creation, production, and distribution of UNBOUND was made possible by the donation of an estimated \$75,000 in professional services, including graphic design, digital interface design, inspirational content creation, public relations, and project management services. Deep Heart also received donations of packing materials from local businesses, including Walmart and Home Depot, with an estimated value of \$2,500. Beginning in September of 2020, Deep Heart donated and shipped over 25,000 hard copies of UNBOUND to multiple correctional facilities in each of the fifty states for a total of 244 DOC and BOP facilities. UNBOUND was also mailed directly to 400 individual inmates and their family members. In addition to this, Deep Heart donated UNBOUND to be used as content directly accessible on inmate's tablets through correctional facility media platforms, such as JPay in KS, AZ, OH, and ME, and Endovo nationwide. This exponentially increased distribution, making UNBOUND available to over 300,000 inmates across the US. The magazine was well-received, by inmates and DOC staff alike, as a valuable mental health resource in a year of increased isolation and restrictions. Feedback has been overwhelmingly positive with statements like "instant sensation", "exactly what we needed", "we can't thank you enough!", "never seen anything like it", "our population is engrossed in UNBOUND" and "We'll take as many copies as you can send" proving the value of this program.
