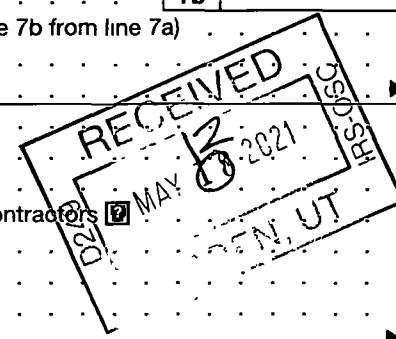

under-served communities by providing milk and vitamins are carried out by funding feeding projects in schools. During this pandemic and subsequent lockdowns, grocery items are provided as well to families in need of assistance. For 2020, the outreach served about 325 children and 150 families.

Part III, Line 30 : Disaster and Emergency Relief - \$9,208

Children and their families, displaced by devastation brought on by natural calamities like floods, volcanic eruption, earthquakes etc are provided relief and emergency assistance. Best example is our first hand experience in 2020.

What was planned to be a simple distribution of some 5000 N95 masks flown in to the Philippines from the United States for devastated residents affected by a volcano eruption, CHC gathered several volunteers and disaster relief goods and distributed same at thirteen (13) settlement shelters, CHC shared blessings to about 25,000 people needing assistance.

Part III, Line 31, Other Program and Services: Special Outreach Programs - Distance Learning Support Project - \$1,000

Project supported learning needs of children in poverty-stricken communities for school year 2020-21. Reached several groups of students. Over 500 students from K-12 received instruction from home as part of the required social distancing precautions to avoid spread of Covid-19. Distance learning needs include materials for online instruction, off-line educational tools, printing materials and equipment.

Special Outreach Programs - One Time Feeding Assistance - \$200

This is an ongoing feeding program brought to CHC's attention by one of our volunteers. The program is called Communal Pot run by a Swedish lady who now lives in the Philippines. It is a free meal distribution for the very poor children in El Nido, Palawan, Philippines. Our small donation purchased a few more rice, meat and vegetables for the meals prepared by local volunteers. Communal Pot reaches around 350-400 hungry impoverished children in the area.
