Line 28 - Collective Kickback Pilot [Complete] In November, we began preparing for the Restorative Community Project through a series of 5 afternoon dialogues, or "kickbacks," with teenagers from West Philadelphia. We paid 6 teens from YEAH! Philly, a 501(c)(3) organization providing hangout spaces for teens from West and Southwest Philadelphia, \$150 to attend the sessions, share their own unfiltered perspectives on restorative justice and community safety, and provide feedback on our teaching style. We utilized restorative practices to discuss and heal from painful social issues directly affecting youth in West Philadelphia, such as educational inequity, gun violence, and police brutality. We collected feedback through pre- and post-surveys and used the final session to collect general feedback. Our first two sessions (November 8th and 10th) took place in-person (note: we utilized a COVID-19 symptom tracker, practiced social distancing, signed an engagement compact, and required masks at all times) at the ECO Foundation in West Philadelphia; however, due to rising COVID-19 cases, we 4 moved to a virtual platform for the remainder of the programming (November 15th, 17th, and 21st). After experiencing a dip in attendance during our first virtual session, we realized additional check-ins between sessions are needed to ensure connectivity – both literally and figuratively. Here are several insightful findings from the pre- and post-surveys:

a. 5 out of 6 participants felt more comfortable talking about their emotions with others as a result of our dialogues.

b. 5 out of 6 participants were more likely to trust being vulnerable around other people after our Collective Kickback.

c. 4 out of 6 participants felt more prepared to talk about community violence when it occurs in the future.

d. All 6 participants felt that other participants in Collective Kickback understood their emotional experiences better after these sessions.

e. All 6 participants stated that they were likely to utilize restorative practices as a tool to address community conflict

f. All 6 participants felt our programming was relevant to youth in West Philadelphia.

g. All 6 participants would recommend our programming to other youth in West Philadelphia.

Furthermore, many participants expressed interest in staying closely involved with our organization moving forward. Their feedback and our internal reflections helped us move forward in planning the Restorative Community Project.

Part IV - As part of the University Pennsylvania 2020 President's Engagement Prize, the founding team the University provided each member of the founding team a living stipend of \$50,000 to cover their salary from July 2020 to June 2021.
