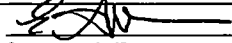

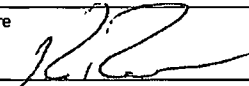

Early in the year, we finalized our initial business plan and program design, signed a lease on our building, and furnished the apartments for our housing program and classrooms for our early childhood education program. We were able to open our housing program in May 2020, welcoming 6 single mother refugee families over the remainder of the year, all of whom were in dire need of housing during the pandemic. We also piloted our early childhood programming with families interested in enrolling their children in 2021, and collected feedback to ensure our program would meet their needs for childcare and education.
