990 EZ Part I, Line 10 - The non-profit was set up to help football players fundraise to cover the fees required by the district and the school to participate in football. Additionally the team fundraises to pay for new equipment - helmets, shoulder pads, uniforms for the players.

990 EZ Part I, Line 16 - The non-profit also fundraises to cover general costs of running the football program.

990 EZ Part III, Line 31 - The non-profit awards scholarship for exemplary player's college and All State Football game.
