Bell Road, Suite 105, Surprise, Arizona 85378. The boutique is the facility where all are welcome to shop, seek prayer, assistance, support, and to be refreshed in a caring environment. Arts and crafts are offered for a nominal fee on perodic basis. Son Glow Ministries Inc. and other 501 (c) (3) organizations in the area provide assistance to individuals seeking food, clothing, and administrative assistance with job interviews and/or homelessness. Some of the same individuals, along with customers, also attend Bible study, and other classes held in the boutique after business hours, however, these activities were suspended in order to comply with the CDC guidelines imposed due to COVID-19. The ministry team members who staff the boutique minister downtrodden by praying with them upon request, paying for meals at nearby restaurants, and paying for transporation home for the occassional stranded soul. The number of individuals assisted, the type of assistance provided, and the cost of the assistance is recorded on the boutique's daily sales record on the day the assistance is provided. Supported organizations are vetted by local churches, school counselors, other charitable organizations, and/or referral by organizations with which Son Glow Ministries Inc. has developed a close working relationship. Supported activities are monitored through observations and site visits by the ministry team or members of Son Glow Ministries Inc's Board of Directors.
