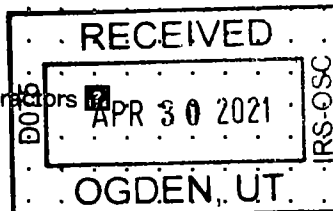



Part II - Community Bible School received a large donation of \$240,000 from an estate in 2011 to support our ministries in Nepal. It was decided by the board of directors to invest the money and use the interest from the investment to support our ministries in Nepal. Per our conflict of interest policy, a committee of 7 members, (which did not include any disqualified person or persons with a conflict of interest), unanimously voted to loan \$120,000 to Greg and Teresa Miller, who are both officers and directors in 2017. The terms of the loan was 5 years, interest at 5%, payable monthly and secured with a first mortgage on a rental property owned by Greg and Teresa Miller. All documents were prepared by a lawyer and recorded with Snohomish County, State of WA. Note matures 2/1/2022.

Part IV Note ** - Greg and Teresa Miller (husband and wife and directors and officers of Community Bible School) have leased to Community Bible School the facilities that it uses for its Bible Conference, retreats, and church services for 26 years now. This property is 45 acres which includes two conference buildings, two single dwelling residences, two one bedroom apartments, meeting rooms, shop buildings, and lake property. The facilities are able to accommodate 60 people overnight with dining and commercial kitchen facilities. The lease in 2020 was \$6003 per month plus taxes and insurance. The current lease expires in 2026. For the convenience of Community Bible School, Greg and Teresa Miller use one of the personal residence located on the property. Total lease including real estate taxes being reimbursed was \$85013 in the year 2020.
