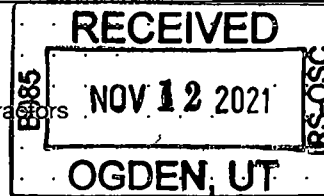



Coast Range Association staff play a leading role in the OMRP communications program.

Our program focus addresses the political economy of industrial forest ownership and its use of financially driven forest management.

Such management does not grow the most timber, exports forest value to distant owners and impacts water quality and forest wildlife.

We released a major proposal for industrial forests in 2020 incorporating a balance of people and nature and the need to sequester

atmospheric carbon. We continue to build public support for the climate-people-nature centered management of industrial forests.

Additionally, we work for Oregon Forest Practices Act reform within the broad framework of the Forest Waters Coalition.
