PMBA annually arranges a day-long educational program for beekeepers, new and experienced; it is open to the public to provide an understanding of the importance of beekeeping locally as well as commercially. Bee Day includes two lecture presentations, including for example, Oregon State University (OSU) apiculture research staff. Bee Day also includes two field sessions, presented by member volunteers, for attendees to gain hands-on experience with honey bees in open hives; finding eggs, brood, queen, and gain an understanding of practices, such as testing for mites. Additionally, PMBA holds a raffle of equipment and supplies donated by beekeeping suppliers and local businesses (e.g., bee friendly plant material donated by a local nursery). PMBA also provides items for the raffle. The event is held at Foothills Honey in Colton, Clackamas County, Oregon mid-spring at no cost to PMBA for the venue. Attendees pay a registration fee which includes the educational and field components along with refreshments and lunch. For 2020, however, Bee Day was postponed until summer initially, then ultimately cancelled as a result of the COVID-19 pandemic.

PART V, LINE 34: Changes to PMBA constitution

IRS requested PMBA amend the constitution to include an updated & acceptable dissolution of organization clause. The membership voted to revise the constitution accordingly in July, 2020. In addition, PMBA officers added a conflict of interest policy to the governing documents.
