IS ORGANIZED AND OPERATED EXCLUSIVELY TO (1) ADVANCE SCIENTIFIC KNOWLEDGE IN THE FIELDS OF NEUROSCIENCE AND PSYCHOLOGY THROUGH THE DEVELOPMENT OF OPEN SOURCE, (2) ADVANCE EDUCATION IN NEUROSCIENCE AND PSYCHOLOGY, AND (3) PROMOTE BRAIN HEALTH AND MENTAL HEALTH. THE MANY BRAINS PROJECT'S CORE MISSION IS TO CURATE AND BROADLY DISSEMINATE HIGH-QUALITY, OPEN SOURCE, WEB-OPTIMIZED NEUROCOGNITIVE ("BRAIN") TESTS FOR SCIENTIFIC RESEARCH AND EDUCATIONAL USE.
