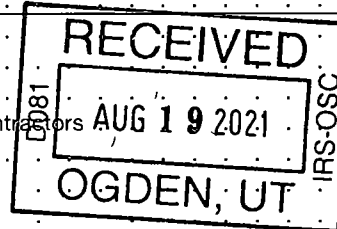



Statement 2 – John Thurman Great Smoky Mountain Trout Adventure Camp is a Council sponsored *non-school related* program for youth ages 12- 15 designed to instill the importance of conserving, protecting and restoring our aquatic resources. The program, in its tenth year, renamed the John Thurman Trout Adventure Camp, after its founder and longtime camp director, John Thurman, offers campers an opportunity to study aquatic invertebrates, stream hydrology, cold water ecosystems and the fundamentals of fly fishing and fly tying. The program is based at the Great Smoky Mountain Institute at Tremont. Additional information is located at tntroutadventure.org. Due to the global pandemic and restrictions, the 2020 Camp was cancelled.

Statement 3 – Trout in The Classroom is a Council Sponsored *school related* environmental education program in which students, grades K through 12, raise trout from eggs to fry, monitor tank water quality and engage in stream habitat study. The objective of the program is fostering a conservation ethic, appreciation of water resources and understanding the ecosystem. The programs end the year by releasing the trout in a state-approved stream in cooperation with the Tennessee Wildlife Resources Agency (TWRA).
