THIRD, NCVLI CONTINUED TO DEVELOP AND MAINTAIN ITS MEMBERSHIP ALLIANCE, THE NATIONAL ALLIANCE OF VICTIMS' RIGHTS ATTORNEYS & ADVOCATES (NAVRA), WHICH HAS A NATIONAL AND INTERNATIONAL MEMBERSHIP OF ATTORNEYS, ADVOCATES, AND STUDENTS.
