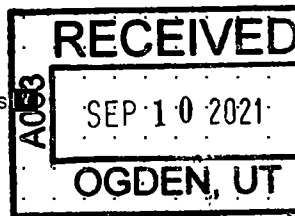

Then from its thrift store profits it makes contributions to other local community non-profit 501(c)(3) organization via a grant process.

Form 990-EZ Part III Line 28 - The biggest accomplishment for 2020 was getting through COVID-19 and even though we were fully closed for 4 months of 2020 and for the 8 months open we operated at a reduced level of 3 days a week ECA was able to increase average daily sales to \$1,026/day for 2020 vs \$840 per day for 2019. Because of COVID-19 2020 revenues of \$109,671 were reduced 46.4% from 2019 revenues of \$204,649. ECA was forced to maintain an equal reduction of expenses of 45.9% from 2019 expenses of \$208,347 to \$112,818 in expenses for 2020. Even with that the organization was still able to issue grants totally \$19,225 to 21 different organizations. For the immediate future the organization Eastside Community Aid will continue to operate at a reduced level because of COVID-19. The organization will continue to evaluate the COVID-19 information and will consider increasing operations & grants when the organization and its members feel that it is safe to do so and when the organization has volunteers to staff the thrift store.
