DISCLOSE THE SITUATION MORE BROADLY AND INVITE DISCUSSION/RESOLUTION BY THE FULL BOARD OF WHAT ACTION TO TAKE, OR C. REFRAIN FROM TAKING ACTION AND OTHERWISE AVOID THE CONFLICT.
