EMPLOYMENT AND TRAINING: HRA'S EMPLOYMENT SERVICES CENTER HAS OVER 14 YEARS OF SUCCESSFUL EXPERIENCE HELPING YOUTH OBTAIN EMPLOYMENT AND EDUCATION TO LEAD THEM TOWARD SELF-SUFFICIENCY. OUR STAFF IS WELL-VERSED IN CWP CAREER COMPETENCIES AND JOB DEVELOPMENT WITH A WEALTH OF EXPERTISE IN ADMINISTERING SUBSIDIZED EMPLOYMENT PROGRAMS, INCLUDING WORKPLACE OVERSIGHT AND/OR INTERNSHIPS. WE HAVE ESTABLISHED SOLID RELATIONSHIPS WITH VARIOUS LOCAL EMPLOYERS AND ARE ACTIVE MEMBERS OF THE LOCAL CHAMBERS OF COMMERCE. WE ARE ALSO ACTIVE MEMBERS OF THE NEW BRITAIN YOUTH COALITION, THE AFTER SCHOOL NETWORK AND HAVE LONG-TERM RELATIONSHIPS WITH COMMUNITY PARTNERS THAT SUPPORT YOUTH WITH DISABILITIES, MENTAL AND BEHAVIORAL HEALTH ISSUES AND SUBSTANCE ABUSE. IN 2019, HRA RECEIVED UNITED WAY FUNDING FOR OUR PILOT PROJECT, "LEARN AND EARN," WHICH TARGETED YOUNG PARENTS IN OUR EARLY CHILDHOOD EDUCATION (ECE) PROGRAM BETWEEN THE AGES OF 18-24 TO CONNECT THEM TO POST-SECONDARY EDUCATION AND EMPLOYMENT. THESE YOUNG PARENTS WERE EITHER UNEMPLOYED OR UNDEREMPLOYED. MOST DID NOT GRADUATE FROM HIGH SCHOOL. WE CREATED A MODEL THAT CO-LOCATED COUNSELING AND COACHING SERVICES IN NEW BRITAIN WHERE PARENTS ALREADY RECEIVED HEAD START FAMILY SUPPORTS. BY MEETING THEM "WHERE THEY ARE AT," OUR STAFF SERVED 35 YOUNG PARENTS, WITH 14 OF THESE PARENTS ENTERING EMPLOYMENT AT OR ABOVE \$16/HOUR. TOTAL DIVISION EXPENSES \$463,230. HEALTH AND WELLNESS : HRA IS THE ONLY ORGANIZATION IN NEW BRITAIN THAT PROVIDES SUPPORTIVE HOUSING TO PEOPLE WITH HIV/AIDS. IT HAS BEEN PROVIDING CULTURALLY APPROPRIATE SUPPORTIVE HOUSING SERVICES TO PEOPLE LIVING WITH HIV/AIDS FOR THE PAST TWENTY (20) YEARS. EVERY CLIENT RECEIVES COMPREHENSIVE CASE MANAGEMENT SERVICES ALONG WITH RENTAL SUBSIDIES SO THAT THEY WILL MAINTAIN A STABLE LIVING ENVIRONMENT. CASE MANAGEMENT SERVICES ARE FUNDAMENTAL TO NATIONAL AND STATEWIDE PERFORMANCE STANDARDS. ALL CLIENTS MEET WITH THE SUPPORTIVE HOUSING CASE MANAGER TO DEVELOP AN INDIVIDUAL CARE PLAN WHICH THE CASE MANAGER REVIEWS EVERY SIX MONTHS. THE CASE MANAGER WILL CONNECT CLIENTS TO BENEFITS, PRIMARY HEALTH CARE, MEDICATION ADHERENCE, SUBSTANCE ABUSE TREATMENT, COUNSELING, CRISIS INTERVENTION AND OTHER SERVICES. IN ADDITION, THE CASE MANAGER WILL BE A LANDLORD ADVOCATE. HRA'S SUPPORTIVE HOUSING FOR PEOPLE WITH HIV/AIDS HISTORICALLY RECEIVES FUNDING FROM BOTH THE CITY OF NEW BRITAIN CDBG AND FROM THE CITY OF HARTFORD CDBG TO SERVE PEOPLE IN NEW BRITAIN AND CONSISTENTLY EXCEEDS THE CONTRACTED GOALS.
