THE COMMITTEE DOCUMENTS THE REASONS WHY ITS RECOMMENDATIONS ARE REASONABLE IN THE MINUTES OF ITS PROCEEDINGS. THIS PROCESS WAS LAST CONDUCTED IN THE SPRING OF 2021, AND THE FULL BOARD APPROVED A 3% COST OF LIVING INCREASE FOR THE EXECUTIVE DIRECTOR, TO BE IMPLEMENTED AT THE START OF THE NEXT CALENDAR YEAR (2022) AND DOCUMENTED IN ITS MAY 13, 2021 MEETING MINUTES. A SIMILAR PROCESS WAS UNDERTAKEN IN THE SPRING OF 2020, WITH THE SAME RECOMMENDATION FOR A 3% COST OF LIVING INCREASE, WHICH WAS IMPLEMENTED IN JANUARY 2021.
