GRANTS SUPPORTED NATIVE-LED ORGANIZATIONS AND TRIBES THAT EMPOWERED COMMUNITIES TO INITIATE OR DEEPEN A COLLECTIVE AND STRATEGIC NETWORK TO INCREASE ACCESS TO HEALTHY AND AFFORDABLE FOOD, FOOD SOVEREIGNTY, NUTRITION EDUCATION, AND PHYSICAL ACTIVITY OPPORTUNITIES. THESE GRANTS SUPPORTED TECHNICAL SUPPORT, COLLABORATION OPPORTUNITIES AND INSPIRATION WITHIN THEIR ORGANIZATIONS TO STRENGTHEN THEIR WORK TO IMPROVE AND SUSTAIN NATIVE CHILDREN'S HEALTH.

THE COACHES TEACH ABOUT HEALTHY FOOD AND NUTRITION SO YOUTH CAN MAKE POSITIVE HEALTHY LIFESTYLE CHOICES. THE YOUTH ALSO LEARN LEADERSHIP SKILLS, INCORPORATING CULTURAL VALUES WHERE APPROPRIATE, INCLUDING RESPECT, SELF-PERSISTENCE, TEAMWORK, AND SELF-DISCIPLINE. IN FISCAL YEAR 2021, PARTICIPANT NUMBERS WERE SIGNIFICANTLY LOWER THAN NORMAL DUE TO THE ONGOING PANDEMIC. NB3 FOUNDATION SERVED 134 YOUTH (UNDUPLICATED NUMBERS) THROUGH VIRTUAL AND, WHEN POSSIBLE, IN-PERSON PROGRAMMING. NB3FIT WEEK: A NATIONAL WEEK OF NATIVE YOUTH HEALTH AND FITNESS HELD EACH NOVEMBER. ACROSS THE COUNTRY, TRIBES, NATIVE COMMUNITIES, ORGANIZATIONS, SCHOOLS, FAMILIES, ETC. HOST PHYSICAL ACTIVITY EVENTS TO SUPPORT THE HEALTH AND FITNESS OF NATIVE YOUTH. OVER THE PAST FIVE YEARS, WE HAVE ENGAGED OVER 10,000 NATIVE YOUTH ANNUALLY THROUGH OVER 125 REGISTERED SITES AND OVER 400 PHYSICAL ACTIVITY AND HEALTH-CENTERED EVENTS IN 24 STATES.

THIRDLY, COMMUNITY EMPOWERMENT VIA THE INDIGENOUS EVALUATION AND NATIVE YOUTH ON THE MOVE GRANT CYCLE ASSISTED COMMUNITY PARTNERS IN DEVELOPING THEIR PROGRAM EVALUATION METHODS WHILE ALSO ALLOWING FOR COLLABORATION VIA ONLINE GATHERINGS/TRAININGS. DURING THE PANDEMIC, THE GRANTMAKING TEAM HOSTED A VIRTUAL VISITING RELATIVES ONLINE GATHERING TO PROVIDE AN OPPORTUNITY FOR COMMUNITY PARTNERS TO SHARE HOW THEY ARE "PIVOTING" PROGRAMMING. CREATING SPACE FOR CONVERSATIONS TO SHARE IDEAS AND CONCERNS ON HOW BEST TO KEEP MOVING FORWARD, ESPECIALLY WITH THE UNKNOWN WAS AN IMPORTANT COMPONENT. THE EVALUATION TEAM WAS ABLE TO SHOW VIA AN INFOGRAPHIC THE VARIOUS METHODS THEY ARE EVALUATING SUCH AS MOVING TOWARD THE USE OF ONLINE SURVEYS AND ONLINE OBSERVATION ENGAGEMENT. FROM 2020 TO 2021, THE NB3 FOUNDATION HAD THE HARD TASK OF LINKING THE OVERALL ORGANIZATIONAL MISSION (PHILOSOPHY) TO OUTCOMES. AT FIRST BLUSH, IT SEEMS LIKE AN EASY REACH HOWEVER, THE GROUP APPLIED INDIGENOUS HEALTH MODEL PRINCIPLES INTO THE WORK. CONVERSATIONS WERE BASED ON A SOCIO-ECOLOGICAL MODEL AND CORE AREAS THAT PROVIDE A FRAME WHERE ACTIONS OR INTERVENTIONS CAN AND ARE BEING DESIGNED. THIS DEPARTMENT ALSO COLLECTED AND ANALYZED DATA ON COVID-19'S NEGATIVE IMPACTS WITHIN NATIVE AMERICAN YOUTH AND HIGHLIGHTED A GAP IN EDUCATION AND EXPERIENCE REQUIRED TO DEAL WITH ECONOMIC AND HEALTH ISSUES. FROM THE CAMPAIGN, 216 SURVEYS WERE RECEIVED AND ANALYZED WITH SUPPORT FROM THE CHARLES AND LYNN SCHUSTERMAN FAMILY FOUNDATION. THERE WERE RESPONDENTS FROM 18 DIFFERENT STATES THAT SHARED THE BEST TIMES TO HAVE A VIRTUAL PROGRAM AND TOPICS OF INTEREST TO THEM. INTERESTINGLY, 80% OF YOUTH ARE INTERESTED IN INTERGENERATIONAL LEARNING (INVITING ELDER TO SHARE WISDOM, ART, OR STORIES).
